PRIVACY POLICY

Farmers Independent Telephone Co and Grantsburg Telcom, Inc. (“FITC AND GT” or “Company”) is committed to protecting its customers’ privacy. Please review this Privacy Policy to better understand how FITC AND GT collects information, how that information is used and your options as to the collection and use of information. This Privacy Policy is applicable to FITC AND GT’s customers and to visitors of FITC AND GT’s website and is intended to provide information regarding FITC AND GT’s methods for collection and use of information.

What types of information does FITC and GT collect?

Whether you are communicating with FITC AND GT or using a FITC AND GT service, FITC AND GT may collect two types of information: personal information and non-personal information. “Personal information” refers to information that is particular to you, such as, your name, address, phone number, fax number, and e-mail address. “Non-personal information” refers to information that does not by itself identify a specific individual. This information includes websites visited, network traffic data, services and features used or call record details.

How do we collect information from you?

FITC AND GT may collect information from you through communications such as via the web, or by phone, email or mail delivery, visiting our office or through the services provided to you as the customer.

Information may be collected in the following ways:

• **Browsing our site**

- IP addresses may be collected for the purposes of system administration, to gather broad demographic information, and to monitor the level of activity on our site.
- Information may be collected regarding the referring URL, which browser you used to come to our site, and the pages of our site that you viewed during your visit and any search terms entered on our site.
- E-mails may be sent by the customer to FITC AND GT on this website. FITC AND GT may retain the information in any e-mail that you send to us, such as your name, e-mail, address, or telephone number.

• **Broadband Internet Service**

- FITC AND GT may monitor the network and take measurements of network performance and the performance of your Internet connection to improve the customer’s, or FITC AND GT’s, overall service levels.
- during communications with FITC AND GT for service support, we may also access information about your customer premise equipment such as computers and wireless modem devices or other device settings to provide customized technical support or to install specific applications or services for your use.

-FITC AND GT reserves the right to access broadband traffic from individual accounts for the purposes of general maintenance and management of the network, as well as upon request by law enforcement officials.

- **Provision of Information by Third Parties**

-FITC AND GT may obtain credit information about you from third parties when you purchase products or services from FITC AND GT.

How is your personal information used?

FITC AND GT uses your information in connection with delivering its products and services to you. FITC AND GT may also use the information supplied in order to personalize portions of your service. Some of these personalized services are made available directly by FITC AND GT, while others may be offered by its content partners. In addition, FITC AND GT analyzes and evaluates customer preferences, comments and criticisms of its offerings in order to make improvements to the present and future versions of the individual service.

FITC AND GT may use personal information it collects to provide you with information or samples that you have requested. In addition, we may use the non-personal information we collect to provide you with a better service experience in the future. FITC AND GT does not rent, sell or trade your private information to any non-affiliated third party.

How does FITC AND GT protect your personal information?

FITC AND GT takes reasonable precautions to protect your personal information against unauthorized access by requiring employees to use secured access authentication and passwords to obtain customer information and by storing electronic file information on a secure server, which is accessible only by authorized personnel.

Unfortunately, no data transmission over the Internet can be guaranteed to be 100% secure and we will not be held liable should a third party illegally obtain your personal information via Internet transmission. While we have made significant efforts to protect your personal information, we cannot ensure or warrant the security of any information you transmit to us and you do so at your own risk.

FITC AND GT takes special care to protect the safety and privacy of young people using its services. FITC AND GT does not knowingly collect information about children. FITC AND GT believes that children should get their parents' consent before giving out any personal information. FITC AND GT encourages parents and legal guardians to participate in their child's experience using FITC AND GT's services. Children should always ask a parent for permission before sending personal information to FITC AND GT.
